- Access Producers' University from Cigna for Brokers or log on at <u>CignaMedicareProducers.com</u>
- Complete all the required training on your learning track or take advantage of our test-out option
- Pass each exam with a score of at least 85%
- You'll have 3 attempts to pass each course
- <u>Launch</u> and complete AHIP (America's Health Insurance Plans) or Pinpoint Medicare Training directly from your track
- You can also upload a certificate from NABIP (formerly NAHU)

- Returning agents are again exempt from completing the Selling with Integrity course.
- VBE HRA training is no longer a separate or standalone course –
 We have embedded the content as a downloadable PDF in
 Our Compliance Program.
- There is no separate PDP certification for agents who hold licenses in our MAPD states. The MAPD Products and Benefits Overview qualifies you to sell our Standalone PDP plans, which will be commissionable for sales effective as of 1/1/2024.
- Agents who only hold licenses in states where Cigna does not have an MAPD product will be assigned the standalone PDP course on the PDP-Only track.

AHIP Reimbursement

Cigna will reimburse the cost of your **AHIP (\$125)**, **Pinpoint (\$99.95)**, or **NABIC** (\$100) certification if you:

- Complete all 2024 certification requirements by September 1, 2023
- Sell at least six (6) fourth (4th) quarter 2023 or January 1, 2024, MAPD plans (PDP plans do not apply, and fourth quarter sales must be effective Oct 1, Nov 1, or Dec 1, 2023)

External Call Center Agents are not eligible for reimbursement under this policy.

IMPORTANT INFORMATION

You may log on to Producers' University to launch your AHIP certification.

- If you have already completed AHIP, simply <u>click this link</u> and log on to the AHIP site to transmit your completions to Cigna (no need to manually upload a certificate)
- You can launch the Pinpoint certification directly from your assigned learning track
- Agents taking NABIP (formerly NAHU) will need to manually upload their certificates to Producers' University

Important Note:

If you started 2023 certification and did not successfully complete all requirements including uploading your AHIP certificate prior to our system updates on June 22nd, you are not certified to sell 2023 products/plans. The good news is that 2024 certification also certifies you for the remainder of 2023.
